My assumption, as you're reading this, is that you are walking from the mailbox to the recycling bin. Depending on your ambulatory rate, we have just a couple of minutes to update you.



### What is a share of stock?

A share of stock is a right to partial ownership in a corporation. It gives the owner a claim on the assets, earnings, and dividends of the corporation.


There can be different classes of stock, some have more rights than others. For example, a class of shares may have 10 times the voting rights of another class. Founders of corporations often use this to retain voting control.

Index funds hold shares of stock in many companies or bonds. We then buy shares of the index fund for clients.

Over the past 3 years, the entire mutual fund industry of 4,000 firms (firms, not funds), took in a net amount of \$97 billion. Combined. Multiply that total by 8.5, and it equals the amount Vanguard received alone.

#### Savings Add Up.

My basketball teammate in junior high school loved to buy Air Jordan's. They were released in 1985 at \$65 per pair. He bought many pairs. But had he bought Nike's shares in 1985 instead of just one pair of Nike's expensive sneakers, and compounded the dividends back into more shares, what would he have today?

Approximately \$26,000. Saving is good. So is investing.

# Of the indexes we invest in for clients, which one performed best for the first 3 quarters of the year?

Emerging Markets, with a 21.77% gain. Emerging Markets include countries like China, India, Russia, Brazil, South Africa, and many others.

Based on Vanguard emerging markets index fund ETF, which owns stakes in 4,655 companies. This stat assumes dividends from emerging markets are reinvested in emerging markets, which is not how the One Day In July overall model always invests.



## Of the indexes we invest in for clients, which one had the largest dividend increase?

Real Estate, sporting a 42.82% increase in one year in the Q3 dividend. This type of increase is unusual, I would not expect a repeat.

Based on Vanguard U.S. Real Estate ETF. Keep in mind this is a quarterly number, and quarterly fluctuations can be more pronounced than those that are yearly.
